Minutes of meeting →

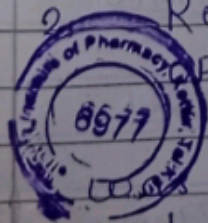
Mrs. priti kolpe madam welcomed all the committee members in her cabin. Following points were discussed →

As there was reconstitution, the various duties and responsibilities were revised again.











